In September 1998, the Esso Gas Plant at Longford near Melbourne exploded killing two men, injuring others and cutting off Melbourne's gas supply for two weeks. The company attributed the accident to errors by operators, but this presentation shows how those errors were induced by a series of organisational factors. The workshop is structured to provide a learning environment through listening to Professor Hopkins on short video clips.
